9.119 Payroll and Disbursement Authorization FY 2013

Authorization to officially empower the superintendent of schools, or his/her designee, to approve payroll and exceptions accounts payable check disbursed by the township treasurer is required to be renewed on an annual basis. A motion to meet this obligation will be advanced for approval.

* 9.120 Temporary Authorization for FY 2013 Expenditures

The authorization to expend district funds emanates from the annually approved budget. In anticipation of the need to encumber FY 2013 expenditures prior to the adoption of the final FY 2013 budget document by the Board, the administration will seek authorization for certain, temporary expenditure levels.
