Dr. Ali reported:

- > SCMI Curriculum Analysis: With help from the South and West Cook areas, we are looking at how to review textbooks aligned to the Common Core State Standards. The SCMI Curriculum analysis process will be ongoing. Teachers and administrators will meet January through June.
- ➢ Gifted: Met on January 30th. Teachers received professional development on systems for identification of gifted and talented students based on the research of Joseph Rensulli, Director of the National Research Center on the Gifted and Talented, University of Connecticut.
- Science: Met on January 31st. The focus of the meeting was Unpacking the Next Generation Science Standards.
- ➤ Language Arts: Met on February 23rd to begin writing language arts curriuculum with a focus on reading and the CCSS. Angela Fortune from SchoolRise was the facilitator.

Attended a conference in Springfield on January 31, along with Dr. Nelson and Ms. Merritt. Attended two sessions on RtI—the Illinois Shared Learning Environment (ISLE) and Common Core State Standards. The ISLE workshop provided information on teacher use of the new integrated assessment system, district technology readiness and professional development.

RTTT Conference

Attended an NCLB Conference February 5-7, 2013. Attended workshop sessions on preparing students for the PARCC assessment, best practices in RtI, STEM, use of technology to teach CCSS, and federal updates on NCLB funding and SES program evaluation. Meadowview teachers Felicia Dawson, Ronneisha Hunt and Leatha Stewart, led by administrators Principal Dr. Joyce Nelson, and Assistant Principal Brenda Richardson, delivered an outstanding presentation on classroom management.

NCLB Conference

The School Improvement Day on February 15th was conducted by SchoolRise consultants in collaboration with the District 160 team leaders. The focus of the professional development was "Vision of the Excellent Graduate" for each school at grades 3,6, and 8 as the first step in developing the staircase curriculum which will be developed to align to the principles of the Common Core State Standards.
